**Tuition fee is designed to cover all expenses at camp except medication and other incidentals. Store account money is not included in the camp fee.*

DISCOUNTS

1. Additional siblings attending camp will receive a \$500 discount.
2. Families who pay in full prior to December 1st will receive 5% off tuition. **Families must contact the office to have this discount applied to your account. It is not automatic.**

PAYMENT POLICY

1. All registrations must be accompanied by the deposit set for that session (\$100 for Mother-Daughter Weekend, \$400 for Mini Camp, \$800 for Term Camp) *per child, per term*.
2. Registration and payment are completed online through our website, www.campalleghany.com.
3. We accept Visa, MasterCard, Discover and e-check.
4. You may log in to your online account and make payments as often as you wish, in any amount, up to April 1, 2027.
5. Any remaining balance will be charged to your account on April 1; you will receive notification a week prior to charging your account.
6. **We reserve the right to assess a 3% service charge on unpaid balances after April 1, 2027.**

REFUND POLICY

1. Withdrawal prior to February 1, all payments **less a \$200 administrative fee** will be refunded.
2. Withdrawal after February 1, *for reasons other than medical*: the full deposit will be kept.
3. Withdrawal after April 1, *for reasons other than medical*: the full tuition will be kept.
4. If one sibling withdraws, any payments made toward that camper may be applied to a sibling less the \$200 administrative fee prior to February 1 or less the deposit prior to April 1.
5. If a full term camper withdraws from one term, the \$200 administrative fee is charged for that term prior to February 1, the deposit is kept prior to April 1, and after April 1 the full amount is kept.
6. If a full term camper withdraws from both terms, the \$200 administrative fee is charged for **both** terms, resulting in a \$400 fee prior to February 1, or \$800 deposit for both terms, resulting in a \$1,600 fee prior to April 1.
